## Molina Healthcare Invites Primary Care Providers: Hepatitis C Screening and Treatment Training

Molina Healthcare is recruiting providers to participate in targeted Hepatitis C (Hep C) training sessions delivered by Project ECHO. Sessions are focused on improving care for Medicaid members facing social drivers of health (SDOH) challenges. The training is designed to equip providers with the knowledge and tools needed to identify, screen, and treat Hep C in populations that often face barriers to accessing timely care. Each two-hour session brings participants together with a team of interdisciplinary specialists for mentorship, didactic based learning, and guided discussion.

Key Points: Hepatitis C Screening & Prevention

- Universal Screening: The CDC recommends one-time hepatitis C screening for all adults aged 18 and older and during pregnancy, regardless of risk factors.
- Frequent Testing for High-Risk Groups: Individuals with ongoing risk factors such as people who inject drugs should be tested regularly to ensure early detection and treatment.
- Importance of Early Intervention: Testing, diagnosis, and timely treatment are critical to:
  - o Preventing serious health complications (e.g., liver disease, cancer)
  - o Interrupting the transmission of hepatitis C within communities
  - Improving health outcomes, especially among high-risk and underserved populations
