60 Day Notice of Enhanced Care Management Rate Change

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to the Medi-Cal line of business.

What you need to know:

Dear ECM Provider

Molina Healthcare of California ("Molina") values its relationship with our ECM Providers and appreciates the services you provide to Molina members. This letter serves as formal notice that Molina will update ECM reimbursement rates paid to contracted ECM providers under the applicable agreement with Molina.

When this is happening:

The updated ECM rates will become effective on **October 1, 2026**, which is at least sixty (60) days from the date of this notice. The rate update will apply prospectively to covered services with dates of service on or after the effective date and will be applied in accordance with the terms of the parties' agreement, applicable law, and applicable government program requirements.

Unless otherwise stated in the enclosed or attached materials, all other terms and conditions of the agreement remain unchanged and in full force and effect.
