Regulatory Training Reminder: Trans Inclusive HealthCare Cultural Humility

Action Required: Complete training and submit attestation by September 8, 2025.

This is an advisory notification to Molina Healthcare of California (MHC) network providers applicable to Medi-Cal line of business.

What you need to know:

Dear Plan Partner,

In accordance with Senate Bill 923, the TGI Inclusive Care Act, Molina Healthcare is dedicated to improving trans-inclusive health care in California. This act highlights the importance of respecting bodily autonomy, avoiding gender assumptions, and treating everyone with compassion and respect.

To comply with these requirements, Molina has partnered with the Transgender Health & Wellness Center to provide essential training to our plan partners. **This training is mandatory and must be completed every two years.**

Upon completion of the training, Molina Healthcare requires a signed attestation to confirm that the training has been reviewed and understood.
