## Molina Provider Enrollment Tool Enhancements/Updates

We are pleased to announce updates and streamlined processes to the Molina Provider Enrollment Tool. These enhancements are designed to improve efficiency and reduce submission errors, making it easier to maintain up-to-date provider information.

- **1. Medicaid Verification Failures** will be generated because the providers Medicaid ID in the V12 account is different than what appears in Medicaid.
  - a. New Enrollment please ensure when adding a provider to your practice/facility that the provided Michigan provider Medicaid ID (not NPI) is entered in the designated MEDICAID ID field at the time of enrollment.
- 2. Roster Submission process has been improved to include the following:
  - File Format Flexibility: You can now upload .CSV or Excel files (.XLS, .XLSX).
  - Enhanced Interface: Our new upload interface detects errors upfront, allowing you to review and correct issues on the spot before final submission.
