

Report of Pregnancy (ROP) Submission Instructions

Non-Delivering Provider

A timely electronic ROP ensures pregnant individuals covered by Medicaid are identified as early as possible so that coverage can be continued through the pregnancy and the immediate 12-month post-partum period.



Provider Benefits and purpose of submitting an electronic ROP:

- An ROP submitted via NurtureOhio updates Ohio's eligibility system, assisting with the prevention of loss of coverage during pregnancy and the postpartum period, enabling more timely receipt of and payment for Medicaid services.
- The ROP serves as pregnancy notification to managed care organizations and promotes initiation of timely health care and connection to prenatal care, as well as added resources, such as care management, WIC, and Evidenced-Based Home Visiting.
- A payment may be made for one report of a pregnancy that is diagnosed in conjunction with an E&M service not associated with a normal obstetrics/gynecology visit. *This payment is separate from the payment for the E&M service (or the encounter or visit of which the E&M service is part).*



Payment for Completing the ROP:

After completing the ROP, submit a claim based on the guidelines below:

Code + modifier	Description	Fee Schedule Amount*
