Changes to Prior Authorization Requirements – Effective November 1, 2026 New Turning Point Musculoskeletal Surgical Procedures Codes (All Lines of Business)

Effective **November 1, 2026**, Molina Healthcare of Washington's prior authorization (PA) requirements will change for the following CPT codes related to Musculoskeletal Surgical Procedures. This change applies to **all lines of business** including **Medicaid, Marketplace, and Medicare**. Beginning November 1, 2026, Molina will require a prior authorization for both participating and non-participating providers for claims submitted for any place of service.

As previously announced in the provider memorandum dated July 30, 2026, "Important Notice of Program Implementation – Turning Point Partnership (All Lines of Business)", Molina Healthcare of Washington will begin collaborating with Turning Point as the administrator for its Musculoskeletal Surgical Procedures.

As part of this implementation, the following codes will require prior authorization through Turning Point effective November 1, 2026.

Beginning September 1, 2026, providers should submit all new prior authorization requests to Turning Point for services scheduled on or after that date using one of the following methods: Providers may start submitting prior authorization requests to TurningPoint starting October 1, 2026 for Medicare, Marketplace, and Medicaid members with dates of service on or after the effective date of November 1, 2026.
