NEW MEXICO:

Hyperbaric Oxygen: Hyperbaric oxygen therapy is a covered benefit only if the therapy is proposed for a condition recognized as one of the accepted indications as defined by the Hyperbaric Oxygen Therapy Committee of the Undersea and Hyperbaric Medical Society (UHMS) or as medically necessary.

Hypnotherapy (Limited) – Hypnotherapy is only covered when performed by an anesthesiologist or psychiatrics, trained in the use of hypnosis when medically necessary or when:

- Used within two weeks prior to surgery for chronic pain management and
- For chronic pain management when part of a coordinated treatment plan

Molina and Passport will cover medically necessary services directly related to non-covered health care services when complications exceed routine follow-up care such as life-threatening complications.

Covered Benefits would be provided through out other Benefit Interpretation Policies. This Benefit Policy is to address any other items that are not covered for each state. Please refer to the not covered section.

Note: In the marketplace, we have limited benefits and need to make sure we cover those procedures that are clearly beneficial in improving outcomes and are medically necessary. This procedure does not significantly improve patient outcomes and therefore it is not a covered benefit.

Please refer to the MHI Clinical Policy titled Medically Necessary Services: Policy No. 332. This policy is applicable only when there is NO existing definition in the member benefit, health plan contract documents and individual health plan state regulations.

Molina and Passport (KY) cover all Medically Necessary basic health services for complications for a non-Covered Service. If a member later suffers a life-threatening complication such as a serious infection, this exclusion will not apply. Molina and Passport will cover any services that Molina or Passport would otherwise cover to treat that complication.

SOUTH CAROLINA:

Services Related to a Non-Covered Service: When a service is not covered, all services related to the non-Covered Service are not covered. This exclusion does not apply to services Molina would otherwise cover to treat complications of the non-Covered Service. Molina covers all Medically Necessary basic health services for complications for a non-Covered Service.



	For example, if a Member has a non-covered bariatric surgery or cosmetic surgery, Molina will not cover services the Member receives in preparation for the surgery or for follow-up care. If the Member later suffers a complication such as a serious infection, this exclusion will not apply, and Molina would cover any services that would otherwise be covered as Medically Necessary to treat that complication. TRAVEL AND LODGING ALL STATES: Travel and Lodging Expenses: Travel and lodging expenses are not covered.
