Availity Essentials is Now Molina's Provider Portal

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

Availity Essentials will be the exclusive secure provider portal for Molina Healthcare for all your eligibility and benefits, claims, authorizations, and more.

Starting **March 28**, the following tools will be accessible <u>ONLY</u> via Availity: **Eligibility and benefits, claims inquiry, claims submission, saved claims, claims template portal, and member search.**

These enhancements are coming soon on Availity Essentials to help you make the most out of working with Molina.

COMING SOON

What To Look For:

You will no longer have direct access to the Molina Legacy Provider Portal after **March 28, 2023.**

Member Search is now live and allows you to search for claims by members' last name, date of birth, member ID, and/or members' first name.

A new **claims correction** feature through Availity Essentials will allow you to correct a paid or denied claim from the claim status response page starting on **April 17, 2023.**

Your Two-Minute Guide to Claims Correction

This brief demo will show you how to use Availity's new claims correction tool in six steps.

Beginning April 17, you will find the new feature under **Claims & Payments > Claims Status**. From the search results, select a paid or denied claim. On the claim status page, select **Correct this Claim**.
