ALZ Direct Connect Referral Program

This is an advisory notification to Molina Healthcare of California (MHC) network providers.

Do you have patients who have dementia? Would you like to provide families with education and support to help them in their caregiving journey?

Molina Healthcare and Alzheimer's Los Angeles have partnered to provide quality dementia care to families in Los Angeles, Riverside, and San Bernardino Counties. Alzheimer's Los Angeles is a local non-profit that providers free care and support to families affected by Alzheimer's and dementia in all stages of the disease.

Through a referral program called ALZ Direct Connect, provider groups and healthcare providers can make referrals to a dementia expert at Alzheimer's Los Angeles.

The ALZ Direct Connect Referral Program connects families to dementiaspecific services and programs that are culturally and linguistically appropriate.

Alzheimer's Los Angeles services include:

- Care counseling/social work support
- Support groups
- Caregiving education
- Early stage services
- Safety devices
- Activity/engagement program
- Respite funds, when available

Making an ALZ Direct Connect referrals is as easy 1-2-3:

- 1) Fill out the ALZ Direct Connect referral form and email or fax it to Alzheimer's Los Angeles.
- 2) An Alzheimer's Los Angeles social worker will reach out to the family.
- 3) Once a connection has been made, you as the referring provider will receive feedback regarding services rendered.

This simple referral form provides your patients and families with the care and support that they need to maintain community-based living with the highest quality of life possible.
