2018 CLINICAL PRACTICE AND PREVENTIVE HEALTH GUIDELINES UPDATE

The Molina Healthcare of California (MHC) Quality Improvement Committee (QIC) annually reviews and adopts evidence-based Clinical Practice (CPG) and Preventive Health Guidelines (PHG) from recognized sources to help practitioners and members make decisions about appropriate health care for specific circumstances.

CPGs define an expected standard of practice for providers specific to membership demographics and service needs. CPGs serve to provide general guidance to providers who are always encouraged to use their best clinical judgment when applying guidelines to their patients.

PHGs set the framework to ensure our members' health and well-being and are associated with Healthcare Effectiveness Data and Information Set (HEDIS) measures. HEDIS outcomes are standardized performance measures that evaluate how many MHC members are receiving care that meets national standards. Many of these HEDIS measures focus on preventive health care that is outlined on our adolescent well care PHG, such as immunizations. Other HEDIS measures look at specific care for chronic illnesses, such as asthma and diabetes.
