# **Provider Profile Sheets: Add Hospital NPI**

This is an advisory notification to the Molina Healthcare of California (MHC) network providers. Beginning January 31 2019, Molina Healthcare will require Provider Profile Sheets to include the hospital NPI for all admitting/affiliated hospital privileges. This will include all new Providers being added to the Network for all lines of business.

### REQUIREMENT

State Legislation Senate Bill (SB) 137 is intended to give consumers accurate, up to date information about which doctors, hospitals, clinics and other providers are in a Health Plan's network. This information will help consumers choose the plan that's right for them as well as reduce the possibility of getting services from an out-of-network provider.

SB 137 requires health plans, among other requirements, to comply with the following requirements:

- Publish and maintain accurate provider directory or directories with information on contracting providers
- Verify provider directory information with contracted providers on a periodic basis.
- Ensure the contracted providers notify the Health Plan when they are accepting new patients or no longer accepting new patients

# **ACTION REQUESTED**

Please update Provider Profile Sheets to include the hospital NPI for all admitting/affiliated hospital privileges. This will include all new Providers being added to the Network for all lines of business. Provider Profile Sheets that do not have the hospital NPI filled out for all admitting/affiliated hospital privileges after January 31, 2019 will be rejected and returned to the IPA/Medical Group for correction.
