What is the overall deductible ?	\$1,750 individual / \$3,500 family	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care , office visits, urgent care , rehabilitation services , habilitation services , diagnostic tests , inpatient services , home healthcare , and preferred generic & brand drugs are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes. \$1,750 individual / \$3,500 family for prescription drug coverage . There are no other specific deductibles. What is the out-of-pocket limit for this plan ?	For network providers \$7,250 individual / \$14,500 family; for out-of-network providers, there is no coverage unless Prior Authorized by Molina Healthcare.	The out-of-pocket limit is the most you could pay in a year for covered services. Does this plan provide Minimum Essential Coverage? Yes.
