Are there services covered before you meet your deductible ?	Yes. Preventive care , Family Planning, Pediatric Vision, Hospice, Home Healthcare services and Formulary Preventive Prescription Drugs are covered before you meet your deductible . Does this plan provide Minimum Essential Coverage? Yes
