What is the overall <a href="#">deductible</a> ?	\$2,100/Individual or \$4,200/Family <a href="#">Deductible</a> applies to <a href="#">Emergency room care</a> , <a href="#">Prescription Drugs</a> , outpatient facilities and inpatient settings.	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. Are there services covered before you meet your <a href="#">deductible</a> ?
