What is the overall deductible ?	\$1,750 / individual or \$3,500 / family	See the Common Medical Events chart below for your costs for services this plan covers.
Are there services covered before you meet your deductible ?	Yes. All covered medical services and Formulary Generic, Preferred Brand, and Preventive prescription drug	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes. \$1,750 Individual or \$3,500/family for prescription drug coverage .	You must pay all of the costs for these services up to the specific deductible amount before this pl begins to pay for these services.
What is the out-of-pocket limit for this plan ?	\$7,250 Individual or \$14,500/family	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit ?	Premiums , balance-billing charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
