What is the overall deductible? Are there services covered before you meet your deductible?	Yes. Preventive care, Primary Care Office Visits, Specialist office visits, rehabilitation services, habilitation services, mental health office visits, substance use services office visits, urgent care, prescription drugs are covered before you meet your deductible.
