What is the overall deductible? Are there services covered before you meet your deductible?	Yes. Preventive care, Office Visits, Inpatient Services, Specialized Scanning Services, Laboratory Tests, Habilitation Services, Rehabilitation Services, Skilled Nursing Facility are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes
