What is the overall deductible?	Yes, a combined <u>deductible</u> . Individual: \$5,800 Family: \$11,600	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Preventive care, Office Visits, Inpatient Services, Specialized Scanning Services, Laboratory Tests, Habilitation Services, Rehabilitation Services, Skilled Nursing Facility, Preferred Generic Drugs, Preferred Brand Drugs are covered before you meet your deductible. Does this plan provide Minimum Essential Coverage? Yes
