Are there services covered before you meet your deductible?	Yes. <u>Preventive care</u> , office visits, <u>urgent care</u> , <u>emergency services</u> , lab work, <u>rehabilitation services</u> , <u>habilitation services</u> , <u>home healthcare</u> and prescription drugs are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes
