What is the overall <u>deductible</u> ?	\$5,800/Individual or \$11,600/Family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. Are there services covered before you meet your <u>deductible</u> ?
