The Molina Healthcare of Nevada leadership team is excited to announce a program in place intended to provide incremental compensation to our providers for delivering these essential visits: **Molina Healthcare of Nevada Commitment to Wellness Push 2025**.

Details of this exciting program include:

- Molina Healthcare of Nevada will sum the incremental \$30 wellness payment for applicable claims into one additional lump sum wellness payment for claims described below.
- Applicable claims will be identified in 2026 and the wellness payment processed by -1/31/26.

The following table applies to the first claim for a Molina Healthcare of Nevada Medicaid member for one of the qualifying codes below submitted and accepted as a clean claim prior to 11/15/2025, for a date of service from 6/1/2025 through 9/30/2025. Providers are eligible for one claim per member.

This excludes members who received qualifying services with a date of service of 1/1/2025 through 5/31/2025.

Only one \$30 incremental payment per eligible Molina member.
