

Prior Authorization Requirements for Urine Drug Screenings (UDS)

Information for providers in all networks

Effective Oct. 7, 2019, Molina will require Prior Authorization (PA) on Urine Drug Screening (UDS) tests per member, per calendar year for:

- greater than 30 for Presumptive and/or
- greater than 12 for Definitive

Molina will be utilizing the **Ohio Urine Drug Screen Prior Authorization (PA) Request Form** that has been published by the Ohio Department of Medicaid (ODM). The Ohio Urine Drug Screen PA Request Form will be posted on Molina's provider website under the "Forms" tab in coming weeks.

Postponed Implementation Date: New Prior Authorization Requirements through eviCore

Information for providers in all networks

Molina Healthcare has postponed our original Oct. 1, 2019 eviCore healthcare (eviCore) implementation date. **The new effective date will be Jan. 1, 2020.**

Molina has contracted with eviCore, an independent specialty medical benefits management company, to provide outpatient utilization management services. eviCore will manage PA requests for the following specialized clinical services, effective for dates of service on or after **Jan. 1, 2020**:

- Imaging and Special Tests
 - Advanced Imaging (MRI, CT, PET, Select Ultrasounds)
 - Cardiac Imaging
- Radiation Therapy
- Sleep Covered Services and Related Equipment
- Molecular and Genomic Testing

Molina and eviCore will continue to provide the scheduled online web orientation sessions as outlined below and will be scheduling additional web orientation sessions as we move closer to the new **Jan. 1, 2020** effective date.
