

CPT II Codes for Blood Pressure Results

When submitting claims, providers should use CPT II codes to report Blood Pressure (BP) results. These CPT II codes are 3074F, 3075F, and 3077F-3080F. The benefits of submitting CPT II codes include:

- Molina can identify providers with a high volume of uncontrolled hypertensive members and offer those provider assistance and support in helping their Molina patients control their BP.
- Providers will receive fewer medical record requests during HEDIS season, and may receive a higher risk adjusted payment for their patients.
- Allows Molina to identify members who have uncontrolled hypertension and, once identified, put appropriate interventions in place to help members control their BP and overall health.

November is National Diabetes Awareness Month

National Diabetes Month is observed every November so individuals, health care professionals, organizations, and communities across the country can bring attention to diabetes and its impact on millions of Americans. This year, the National Diabetes Education Program's theme is: Everyday Reality.

For those who've been diagnosed, diabetes impacts nearly every decision they make daily—from what they'll eat, wear, and do to how they'll take care of themselves. Yet the 24/7 burden of diabetes management is often misunderstood. This campaign is intended to demonstrate the everyday reality of diabetes from the point of view of people living with diabetes or caring for someone with diabetes. And while the everyday of diabetes can seem overwhelming, there are ways we can all help – and to prevent it from becoming the everyday reality for millions more.

According to the American Diabetes Association 4,110 people are diagnosed with diabetes every day. The American Diabetes Association recommends an HbA1c test every 6 months if the patient is controlled or every 3 months if non-controlled, as well as an annual eye exam.

Prenatal Risk Assessment Form

Did you know that you can now submit the Prenatal Risk Assessment Form online? The Ohio Department of Medicaid has created a web-based notification system that allows providers to instantaneously alert the County Department of Job and Family Services and managed care plans of a woman's pregnancy. The creation of this web-based notification system will allow women to be connected with needed services and prevent interruption of their Medicaid coverage.

There are several other advantages provided by the notification system:

- Provider has the ability to submit home health referrals, fax prescriptions for injectable progesterone to managed care plan's specialty pharmacy, and print out prescription for progesterone when needed to prevent preterm births.
- Ability for managed care plans to download member information into care management system for more efficient connection to care.

Well Child Visits

As the end of the year approaches, make sure your patients have completed their annual well-check visit! Molina Healthcare is committed to our members receiving recommended preventive care based
