Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> , office visits, <u>urgent care</u> , <u>emergency services</u> , lab work, <u>rehabilitation services</u> , <u>habilitation services</u> , <u>home healthcare</u> and prescription drugs are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.

Does this plan meet the Minimum Value Standards? Yes

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.
